Welcome to Cinderella, the world's largest pageant program of its kind. Since its inception in 1976, Cinderella has awarded millions of dollars in scholarships and prizes to girls all over the world. Cinderella is a "natural" pageant without the fancy hair, heavy makeup, glitzy clothes and rehearsed routines. Contestants compete in several events:

Meet the Judges: Participants in the Tot-Woman divisions will partake in a "meet & greet" with the judges. This will be in an informal setting and chaperones do not attend.

Photogenic: Contestants bring one picture (typically head and shoulders) that shows their photogenic qualities. Photos will be returned, can be any size up to 8x10 and should have name and age on back.

Party/Formal Wear On Stage: All ages. Contestants will model their dress/gown on stage (dress should be at or above the knee for ages 0-12) (full length formal gown for 13 & up). Babies (0-2yrs) must be accompanied on stage by a chaperone. This "Modeling" is simple and will be taught onstage during a free workshop held before the pageant begins.

Casual Wear On Stage: All ages. Capri outfits, pants, sun-dresses, and skirts are all appropriate (contestants do not generally wear jeans, and hats or props are not allowed). **Baby Playtime** takes the place of this event in the baby pageant. Baby participants will have a group "playtime" in their casual wear attire rather than model it onstage.

Talent: Young ladies ages 7-26 will participate in Talent competition, in order to qualify for the Overall Title in the division. (Without competing in Talent, participant is still eligible for Beauty or Photogenic titles) They may sing, dance, cheer, tumble, read a poem, play an instrument, etc. Time limit is 2.5 minutes. Please bring 2 labeled copies of your music.

Tot Personality: Girls ages 3-6 do not compete in talent, but instead do a short on-stage one-on-one interview with the emcee, called "Tot Personality". An additional outfit is not necessary; Tots will remain in their Party Wear dress.

HONOR ROLL ENTRY OPTION:

For contestants already qualified* to attend the State Finals and would like to enter for the sake of practice & comments. HR participants are not eligible for awards and will receive a participation certificate prior to crowning of winners.

*State Pageant deposit must be received by the State Director before a participant will be eligible to Honor Roll.

AWARDS:

Overall Age Division Winner:

Judged on all phases of competition. One overall winner is each age group will receive: Official crown, trophy, white satin banner and \$75 of their entry fee pre-paid to the state pageant by their local director.

Cinderella Beauty Winner:

Judged on close-up appraisal & on-stage modeling events. One Beauty winner in each division will receive a crown, trophy, banner and \$75 of their entry fee pre-paid to the state pageant by the local director. Alternates will receive official trophy.

Talent/Personality Winner:

Judged on the Talent/Tot Personality only. One Beauty winner and one Talent/TP winner in each division will receive a crown, trophy, banner and \$75 of their entry fee pre-paid to the state pageant by the local director. Alternates will receive official trophy.

Photogenic Girl Winner:

Judged on photo only. The Photogenic Girl winner in each age division will receive a crown, plaque, banner, and \$75 of their entry fee pre-paid to the state pageant by the local director. Alternates will receive official plaque.
